

## Iowa City Intergroup Meeting Minutes – 6/6/26

**Called to order at 10:00 am.**

**Attendees:** Bryan D. (Chair), Dan R. (Co-Chair), Jeff N. (district liaison), Laura H. (Treasurer/Communication), Regan L. (Monday night Tiffin), Tim H. (Tuesday night trudgers).

### Chair Reports

**Secretary (Ryan H.):** May meeting minutes accepted as written.

**Treasurer/Communications (Laura H.):** Treasurer's report attached: Laura requested reimbursement for \$100 for out-of-pocket expenses related to the spring picnic. She noted that we collected only about \$50 at the event, and that several donations of decorations, etc., were needed to make the event happen. Motion to reimburse Laura for expenses approved.

**Chair (Bryan D.):** Thanked everyone for their efforts on the spring picnic.

**Co-chair (Dan R.):** Dan sent out flowchart for how people might handle calls into the AA phone line; he is looking for feedback. The plan is to use this for people answering the phones and also for training. We discussed general training about responding to phone calls from suffering alcoholics.

**Webmaster (Ashley T.):** All events and meetings from District site added; added a "Want to Get Involved?" section to the home page. Laura was charged \$30 from BluHost and Ashley will check and get back to her.

**Phone chair (Heidi W.):** No update

**Intergroup district liaison (Jeff N.):** Meeting minutes are online for those interested. They are working on a business card with a QR code that links to the meeting list to help spread the AA message.

### Group Reports (including emailed reports)

**Breakfast club, Riverside and Solon (Jeff N.):** The Breakfast Club is an open meeting, seven days a week, at 6am, at 511 Melrose in Iowa City. Meeting chairs select the reading from AA approved literature followed by shares. Attendance is strong, weekdays between 15 and 20 people, weekends around 10-15. We are doing a breakfast meeting on the 3rd Friday of every month, July 3-4, breakfast club will hold its meeting as a bonfire meeting at Shelter 5, Lower City Park. Riverside and Solon continue to have approximately 5 attendees, and both are doing well.

**Monday night Tiffin group (Regan L.):** Open discussion meeting 7 pm Monday at Grace United Methodist Church, open with the serenity prayer, read the preamble, how it works, 12 traditions, selection from AA approved literature and open for discussion, then close with the 9th step promises and the Lord's Prayer. Attendance averages about 25 people; only 16 on 5/25 probably due to Memorial Day, but 31 attended on 6/1. Monday, June 8th was a celebration of the group's 20th anniversary (6/5) as well as AA's 91st anniversary (6/10). Showed Markings on a Journey, a short AA video, then Doug B. of Iowa City spoke. There was cake, ice cream, pie, and other snacks.

**Tuesday Night Trudgers (Tim H.):** Closed discussion meeting that meets Tuesdays at 7:30 at Zion Lutheran Church. Our business meetings are held the second Tuesday of each month at 6:45pm at Zion Lutheran. All are welcome to attend and to become home group members. No new business to report.

### **Old Business**

**ICYPAA convention in Iowa City, August 14-16:** Regan reported that the coordinating committee is looking for groups to cover the hospitality room; the committee is also in need of financial contributions to help cover costs. We plan to partner with District 13 to help with expenses and responsibility for one of the bigger meals; as a backup plan, we will revisit making a contribution to the ICYPAA coordinating committee at our next meeting.
